The survey author plays a critical role in the accessibility of the survey. The author is the content creator and therefore has the responsibility to ensure that the content is accessible. Qualtrics web application executes the survey and displays its content to the respondent. Within the survey authoring platform, Qualtrics provides accessibility tools to help the survey author create accessible content.
